# Texas Extension Association of Family and Consumer Sciences Winter Board Meeting <br> Texas 4-H Center <br> December 6-7, 2022 

The Texas Association of Family and Consumer Sciences Winter Board Meeting was called to order by Joanne Ureste-Armijo at 1:12 p.m. on December 6, 2022.

Micah Holcombe introduced guest speaker TJ Cummings to discuss early career agents to attend board meetings to get more new agents involved in associations.

## NEW BUSINESS

PEAC Meeting - What Is PEAC? Professional Extension Association Council - Association Presidents and President Elects meet with ELT (Extension Leadership Team).

President Ureste-Armijo asked districts to submit topics to discuss with ELT. Topics included:

- Questions regarding fee-based programming
- Why do our programs not reference other areas (such as Path to the Plate and Walk-and-Talk); also why are specialists not involved in program (marine agents not included in development of sea food topics)
- Can we fix the Social Media section in TAMED reporting? It is hard to determine followers and posts; make it easier to report.
- Where do we put one-on-one reporting? Or Validation. Or contact hours
- Add in an "Other" area to capture mileage or meals to make it functional as a Commissioners Report. Then it could be downloaded and serve as the CC Report.

Retention issues and pay were discussed at previous PEAC meeting.
State officers met with Extension Leadership Team in November. Discussed annual conference in Decatur, National conference in NC, and goals for association (increase membership and increase professional development).

Committee Assignments - Please ask members to sign up to help on a committee. Especially on Award committees. Kailey Roberts ( $1^{\text {st }} \mathrm{VP}$ ) needs 9 members to help with Awards and Recognition Committee.

2023 Conference Update - The 2023 TEAFCS State Conferenc will be held July 25-27 in Fredericksburg, Texas at the Inn on Baron's Creek. Members can check in on July $24^{\text {th }}$. Board discussed conference start up needs and tips for 2024 conference committee questions.

Members would like family activities included in the 2024 (beach/island location). 2024 Committee is looking at alternate dates to avoid peak season to help keep cost as low as possible.

Conferences in 2025, 2026, and 2027 are also potentially beach locations. Members from those districts asked if the conference location is preferred or if in some of those years, we would like to move inland with in the conference district. Zelina Zavala stressed that the Texas coast varies, and locations will not be similar.

District Idea Sharing - Each District Director shared programming ideas from district.

Bylaws - Sarah Latham reported changes were made to the NEAFCS bylaws at the Annual Session in September. The TEAFCS Bylaws Committee will meet before May meetings and present the changes for discussion at that time.

Member Resources - Amy Ressler discussed ideas to increase membership and requested suggestions from members. Amy has attended Discover Extension meetings and introduced the association to new members. Encouraged continuing the clothing swap at the state meeting to help new agents gain access to Extension apparel. Amy suggested designing an association shirt for members; would like to look at the budget to see if there is a line item available to help with cost. She will present additional information at the May meeting. Members discussed previous gifting of carts to new members. Carts cost approximately $\$ 50$ each and this process stopped due to expense.

Historical - Kelli Brown - No report. Kelli was not in attendance at the meeting.
4-H Foundation - Micah Holcombe will email the 4-H Foundation report to all board members. Scholarship portal is open. General eligibility to apply is no longer limited to top $50 \%$ of class; open to all
(individual scholarships may have their own guidelines). Deadline for scholarship applications is February 15, 2023. The 4-H Foundation Clover Gala will be held on June 8, 2023. In 2022, TEAFCS donated a Consuela bag for the silent auction. Deadline for Foundation grants is December 31, 2022 (earlier than normal); will be awarded in February and must be used by August 31. Micah encouraged agents to support the Foundation Jerky fundraiser. Micah will send out the training on payment/requesting funds and distribute it to agents.

Webmaster, Chris Coon - No report. Chris was not in attendance at the meeting.
